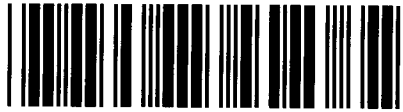

COMMISSION STAFF’S RESPONSE TO ORDER NO. 1

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this response to Order No. 1 and would show the following:

I. BACKGROUND

On May 29, 2015, AEP Texas Central Company (AEP Central) filed a non-standard true-up filing as the servicer of Transition Bonds issued pursuant to the Financing Order in Docket No. 32475.¹ On June 3, 2015, the Administrative Law Judge issued Order No. 1 requiring Staff, on or before June 19, 2015, to file comments on AEP Central’s proposed notice and proposed scope of the proceeding, as well as a proposed procedural schedule.

II. STAFF’S RECOMMENDATION

A. Notice

AEP Central provided notice of the filing to parties to Docket No. 32475, Staff, Office of Public Utility Counsel, all retail electric providers in AEP Central’s service territory, and municipalities and cooperatives who serve customers in areas of dual certification with AEP Central. Staff has reviewed AEP Central’s proposed notice language and method for serving notice and finds them to be appropriate and reasonable notice.²

B. Scope of Proceeding

As the Commission stated in Finding of Fact 97 of the Financing Order, the scope of this proceeding will be limited to determining whether the proposed adjustment complies with the Financing Order.

C. Procedural Schedule

Staff recommends the following procedural schedule:
