MOTION TO INTERVENE**

Texas Energy Association for Marketers ("TEAM")¹ files this Motion to Intervene and respectfully requests that TEAM be granted party status in this proceeding.

I.

TEAM seeks to participate in the above-captioned proceeding pursuant to Public Utility Commission ("Commission" or "PUC") PROC. R. 22.103 and 22.104. The members of TEAM participating in this proceeding are retail electric providers ("REPs") certificated by the Commission to provide retail electric service in regions of Texas within the Electric Reliability Council of Texas (ERCOT). TEAM members access data in Smart Meter Texas for purposes of providing retail electric service to customers in ERCOT. Team members will also be responsible for payment of any charges associated with cost recovery for services approved in this proceeding. Therefore, TEAM has a justiciable interest that may be adversely affected by the outcome of this proceeding and should be granted party status.




