AMENDED PROOF OF NOTICE

Pursuant to *Order No. 1 Establishing Procedural Schedule*, Electric Reliability Council of Texas, Inc. (ERCOT) files this Amended Proof of Notice concerning the *Complaint of Aspire Commodities, LLC Against the Electric Reliability Council of Texas*.

ERCOT filed its original Proof of Notice in this Docket on July 1, 2019. That filing included an affidavit stating that notice of Docket No. 49673 was sent on June 28, 2019, via electronic mail (email), to all Qualified Scheduling Entities (QSEs) and ERCOT's Technical Advisory Committee (TAC). Subsequently, however, ERCOT discovered that the email containing the notice was delivered to certain individual recipients but not to the intended QSE and TAC email distribution groups. Upon investigation, ERCOT determined that this delivery failure resulted from a technical issue associated with the subscription services of ERCOT's listserv application. Accordingly, and as reflected in the attached affidavit, ERCOT successfully resent and delivered the notice of Docket No. 49673 to all QSEs and TAC via email on July 3, 2019.

ERCOT apologizes for any inconvenience this issue may have caused. As always, ERCOT will provide the Commission with additional information upon request.

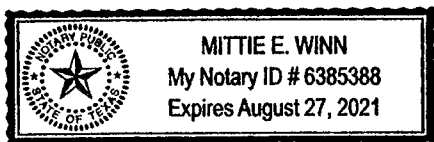


"My name is Erika M. Kane. I am an attorney for Electric Reliability Council of Texas, Inc. (ERCOT). I am over the age of eighteen and competent to make this Affidavit.
