RE: July 18, 2019 Open Meeting, Project No. 49711

SB 1497, 86th Legislature amended Subchapter H, Chapter 39 of the Utilities Code to add Section 39.3555 to provide for registration of brokers. The Act takes effect on September 1, 2019. Persons are not allowed to provide brokerage services without being registered with the Commission. Additionally, retail electric providers may not knowingly provide bids or offers to a person that has not been registered.

To accommodate the September 1 effective date, Staff is providing the attached draft of an interim registration form for your review and discussion at the July 18th Open Meeting. Based on your discussion, staff will make any necessary changes to the form and resubmit for adoption at the August 8th Open Meeting. Adoption of the form will facilitate registrations contemplated by the Act.

Staff plans to initiate a rulemaking project for broker registration later this year that may also address a revised registration form.

Public Utility Commission of Texas Application for Electricity Broker Registration

General Information

Under Public Utility Regulatory Act (PURA) Section 39.3555, any person that provides brokerage services for compensation or other consideration must register as a broker with the Public Utility Commission of Texas (Commission). "Brokerage services" means providing advice or procurement services to, or acting on behalf of, a retail electric customer regarding the selection of a retail electric provider, or a product or service offered by a retail electric provider. Brokers do not sell or take title to electric energy.

Registered brokers must comply with customer protection provisions, disclosure requirements, and marketing guidelines established by the Commission. An administrative penalty may be assessed for failure to comply with PURA or Commission rules.

Registration Form

Answer all of the questions on the registration form completely, providing all relevant information. If substantive changes occur while the application is pending, promptly notify the Commission by filing seven copies (six copies and one original) of the registration form showing the changes with the Commission's Filing Clerk under the control number assigned to the application.

Affidavit

The owner, partner, or officer of the registering person must swear to and affirm the truthfulness, correctness, and completeness of the information provided in this registration by attaching a signed and notarized copy of the Affidavit provided with this registration form.
