STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to the International Brotherhood of Electrical Workers Local Union 738’s (IBEW) First Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 1-2 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹, and are subject to treatment as Confidential protected materials.

The materials provided in response to IBEW RFI No. 1-2 contain non-public commercially sensitive internal operation and forecast information that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Confidential materials designation given to them.


