Certain documents provided in supplemental response to Texas Industrial Energy Consumers' (TIEC) Seventh Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 7-16 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Confidential materials.

The materials provided in supplemental response to TIEC's RFI No. 7-16 contain non-public commercially sensitive internal analyses, forecast-related, technical, and economic comparative data compilations, and other business and operational information that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.




