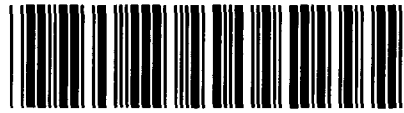

STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to Texas Industrial Energy Consumers' (TIEC) Eleventh Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 11-4 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Confidential materials.

The materials provided in response to TIEC's RFI No. 11-4 contain non-public commercially sensitive operational data, internal compilations projections and analyses, as well as forecast information that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.




