STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to East Texas Electric Cooperative, Inc. and Northeast Texas Electric Cooperative, Inc.’s (ETEC-NTEC) Second Request for Information to Southwestern Electric Power Company (SWEPCO), Question Nos. 2-23, 2-32, 2-33, 2-53, 2-54, 2-56, and 2-58 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Highly Sensitive materials.

The materials provided in response to ETEC-NTEC’s RFI Nos. 2-23, 2-32, 2-33, 2-53, 2-54, 2-56, and 2-58 contain non-public commercially sensitive internal analyses and assessments, including modeling, forecast, and selection process information that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Highly Sensitive materials designation given to them.




