STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to Texas Industrial Energy Consumers' (TIEC) Fifteenth Request for Information to Southwestern Electric Power Company (SWEPCO), Question Nos. 15-5 and 15-7 are exempt from public disclosure pursuant to Sections 552.101, 552.102, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Highly Sensitive protected materials.

The materials provided in response to TIEC's RFI Nos. 15-5 and 15-7 contain non-public commercially-sensitive information, analyses, and compilations related to testing modeling data and inputs as well as price forecast information, that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Highly Sensitive materials designation given to them.


