STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to Texas Industrial Energy Consumers' (TIEC) Sixteenth Request for Information to Southwestern Electric Power Company (SWEPCO), Question Nos. 16-4, 16-6, 16-7, 16-8, 16-18, and 16-31 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Confidential materials.

The materials provided in response to TIEC's RFI Nos. 16-4, 16-6, 16-7, 16-8, 16-18, and 16-31 contain information related internal operating and financial information, confidential contract terms, and internal forecasts and compiled data that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Confidential materials designation given to them.
