Dear Ms. Bowen:

Pursuant to section 25.105 of the Commission's Substantive Rules, please accept for filing this letter and the information set forth herein as the Registration of Illumina Energy Group, LP. (A Texas Limited Partnership), as a power marketer intending to do business in Texas. Enclosed are the original and six copies for the Commission's information and files.

**REGISTRATION STATEMENT OF ILLUMINA ENERGY GROUP, LP PURSUANT TO RULE 25.105**

Illumina Energy Group, LP. ("Illumina") has not yet bought or sold electric energy at wholesale within the ERCOT region. Though registration under Commission Substantive Rule 25.105 is required thirty (30) days after the date Illumina does so, Illumina files this registration statement in anticipation of its engagement in such wholesale transactions.

The information further required by Substantive Rule 25.105 is stated below:

- 1. Provide the power marketer's address and the name, address, telephone number, facsimile transmission number, and email address of the person to whom communications should be addressed; and the names and types of business of the owners (with percentage of ownership).**

Illumina Holdings, Inc. (a Texas Corporation) is the general partner (65% interest). Illumina Holding, Inc. is engaged in the energy business in Texas and North America. The limited partners are all individuals: Hector Carreño (10%), Emil Peña (10%), Frank McCune (10%), and James Cargas (5%).

Illumina intends to engage in the purchase and sale of wholesale electricity as a power marketer doing business in Texas.

**5. Submit copies of all of its FERC registration information, filed with FERC subsequent to the effective date of this section.**


Illumina has made no FERC filings to date.



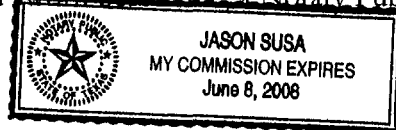
