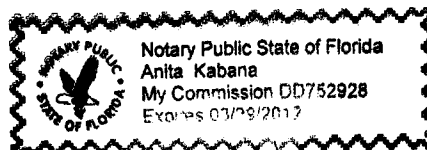

Pursuant to the authority delegated to the Director, Division of Tariffs and Market Development - West, under 18 C.F.R. § 375.307, your submittal filed in the referenced docket is accepted for filing, effective January 1, 2009, as requested.<sup>1</sup>

On January 14, 2009, you filed, on behalf of FPL Energy Power Marketing, LLC, a revised market-based rate tariff reflecting the name change of FPL Energy Power Marketing, Inc. to FPL Energy Power Marketing, LLC.

You additionally included a notice of change in status, stating that the name of FPL Energy Power Marketing, LLC's upstream owner has changed from FPL Energy, LLC to NextEra Energy Resources, LLC. You represent that this change does not affect the conditions the Commission relied upon when granting the FPL Energy Power Marketing, LLC market-based rate authority. Based on your representations, the notice of change in status is accepted for filing.
