**UPDATE TO POWER MARKETER REGISTRATION OF RELIANT ENERGY SERVICES, INC. (NOW KNOWN AS RRI ENERGY SERVICES, INC.)**

Pursuant to PUC Subst. R. 25.105(d), Reliant Energy Services, Inc. (now known as RRI Energy Services, Inc.) (referred to herein as "RES") submits updated information regarding its registration as a power marketer in Texas. RES filed its initial registration on June 22, 1999. RES provides this update in order to reflect the change in name from Reliant Energy Services, Inc. to RRI Energy Services, Inc., effective as of May 2, 2009, in connection with the recent sale of Reliant Energy, Inc.'s retail business to NRG, which closed on May 1, 2009. Affiliates of the Registrant that buy or sell electricity at wholesale in Texas are RRI Energy Electric Solutions, LLC (formerly known as Reliant Energy Electric Solutions, LLC) and Sabine Cogen. Sabine Cogen also sells electricity to its steam host at retail in Texas. Registrant has no other affiliate that sells electricity at retail in Texas or any affiliate that is an electric or municipally owned utility in Texas.




