Eagle Energy Partners I, LP ("Eagle") is registered as a power marketer in Texas pursuant to Public Utility Commission Substantive Rule 25.105.

On November 20, 2008, Eagle reported to the Commission that EDF Trading North America Management LLC ("EDF TNAM") and EDF Trading North America Inc. ("EDF TNA") had acquired all of the ownership interests in Eagle – a change in the ownership interest holders previously identified by Eagle. As of October 31, 2008, EDF TNAM held a 1.49% general partnership interest and EDF TNA held a 98.51% limited partnership interest.

In accordance with Commission Substantive Rule 25.105(d), Eagle hereby notifies the Commission that Eagle underwent an internal corporate restructuring on October 5, 2009. As part of that restructuring, Eagle changed its corporate structure from a Limited Partnership to a Limited Liability Company and was renamed "EDF Trading North America, LLC." Also, EDF TNAM merged with and into EDF TNA thereby consolidating 100% of the Eagle ownership interest in EDF TNA.
