NOTICE OF SELF-CERTIFICATION OF EXEMPT WHOLESALE GENERATOR STATUS

)

Pursuant to Section 366.7(a) of the Federal Energy Regulatory Commission's ("Commission") regulations, 18 C.F.R. § 366.7(a) (2019), IP Titan, LLC ("Titan") hereby submits this Notice of Self-Certification that it is an "exempt wholesale generator" ("EWG") as defined under Section 1262(6) of the Public Utility Holding Company Act of 2005 ("PUHCA") and 18 C.F.R. Part 366.

II. DESCRIPTION OF TITAN

Titan is a Delaware limited liability company that has been formed to develop, own, and operate an approximately 290 MW (AC) (nameplate) solar photovoltaic ("PV") electric generation facility located in Culberson County, Texas (the "Facility"). The Facility is scheduled to achieve initial synchronization in the fourth quarter of 2020. The Facility will be comprised of solar PV panels and associated facilities necessary for the generation of power at wholesale, including a five-mile 138 kV gen-tie interconnection line. The Facility will be interconnected with the transmission system owned by the Lower Colorado River Authority within the Electric Reliability

Council of Texas, Inc. balancing authority area. The Facility will not provide transmission or distribution services for other parties or comprise an integrated transmission or distribution system.

III. REPRESENTATIONS AND INFORMATION REQUIRED BY 18 C.F.R. § 366.7

By this Notice of Self-Certification of EWG Status, Titan self-certifies that it is an EWG within the meaning of Section 1262(6) of PUHCA and 18 C.F.R. §§ 366.1 and 366.7. In support, Titan represents the following:

- 1. Titan is engaged directly and exclusively in the business of owning or operating, or both owning and operating, all or part of one or more "eligible facilities" as defined under Section 32(a)(2) of the Public Utility Holding Company Act of 1935 ("PUHCA 1935") and selling electric energy at wholesale. Consistent with Commission precedent, Titan may also provide to the wholesale purchaser of its electric energy, or to other purchasers, other products derived from and/or incidental to the production and wholesale of electric energy from the Facility, such as ancillary services and environmental attributes associated with the Facility's generation of electric energy (including renewable generation credits). See, e.g., Sithe Framingham, LLC, 83 FERC ¶ 61,106 (1998); Madison Windpower, LLC, 93 FERC ¶ 61,270 (2000).
- 2. The Facility will be an "eligible facility," as that term is defined under Section 32(a)(2) of PUHCA 1935, because (i) it will be used for the generation of electric energy exclusively for sale at wholesale, and (ii) it will include only those interconnecting transmission facilities necessary to effect a sale of electric energy at wholesale. The electricity produced by the Facility will be sold exclusively at wholesale under a long-term power purchase agreement with Calpine Energy Services, L.P., and Titan will neither own nor operate any transmission facilities other than those interconnecting transmission facilities necessary to effect the wholesale sale of electric energy from the Facility.

3. No rate or charge for, or in connection with, the construction of the Facility, or for

electric energy produced by the Facility, was in effect under the laws of any state on October 24,

1992. Accordingly, no determination or certification by any state commission is necessary prior

to Titan obtaining status as an EWG.

4. There will be no lease arrangement through which Titan will lease the Facility to a

public utility company or any other party.

5. Except for other EWGs, no portion of the Facility will be owned or operated by an

"electric utility company" that is an "affiliate" or an "associate company" of Titan, as those terms

are defined in Section 1262 of PUHCA and 18 C.F.R. § 366.1.

IV. SERVICE

As required by 18 C.F.R. § 366.7(a), Titan is concurrently serving a copy of this Notice of

Self-Certification of EWG Status upon the Public Utility Commission of Texas.

V. CONCLUSION

Based on the foregoing, Titan satisfies the requirements for "exempt wholesale generator"

status under 18 C.F.R. § 366.7(a) and respectfully requests that the Commission accept this Notice

of Self-Certification of EWG Status.
