Dynegy Marketing and Trade, LLC, Luminant Energy Company LLC, and Vistra Operations Company LLC (collectively, Vistra Power Marketers) are updating their registrations to report a change in affiliates. Concurrent with this filing, two of the Vistra Power Marketers' affiliates have applied for registration as power generation companies (Brightside Solar LLC and Emerald Grove Solar LLC). In addition, Wharton County Generation, LLC (Wharton), a registered power generation company, is no longer an affiliate of the Vistra Power Marketers following Wharton's sale to another party in the fourth quarter of 2021.
