**AMENDMENT ONE TO
ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT**

This Amendment One ("Amendment") to the W.A. Parish Electric Generating Station Electric Reliability Council of Texas Standard Generation Interconnection Agreement, (the "SGIA") that was originally entered into between Texas Genco Holdings, Inc. and Reliant Energy HL&P dated August 31, 2002, is made between **NRG TEXAS POWER LLC** ("NRG") as successor in interest to Texas Genco Holdings, Inc. and **CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC** ("CenterPoint Energy"), as successor in interest to Reliant Energy HL&P, (collectively, "the Parties") on this 12th day of November, 2007. In consideration of the mutual promises and undertakings herein set forth, NRG and CenterPoint Energy agree to amend the SGIA as follows:

1. NRG made changes to the WA Parish Coal Unit 5 through 8 turbine generator ratings effective on August 1, 2007. In order to reflect this, the Parties agree that Paragraph 4) and 5) of Exhibit "C" to the SGIA, is amended as follows:

4) Number and Size of Generating Units

A) Plant will be comprised of nine (9) generating units with a total rating of approximately 3,647 MW.

5) Type of Generating Units

A) Description

1) Four (4) natural gas/fuel oil fired steam boiler generating units:

Unit 1	General Electric 174 MW	Trfr. No. 1	19/132 kV
Unit 2	General Electric 174 MW	Trfr. No. 2	19/132 kV
Unit 3	Westinghouse 278 MW	Trfr. No. 3	21/142 kV

2) One (1) natural gas fired combustion turbine generating unit:

3) Four (4) coal fired steam boiler generating units:

4) Each step-up, standby and auxiliary transformer will have a disconnect switch or circuit breaker for isolation from the TIF.

2. Exhibit "D" dated June 2002 is replaced with the Exhibit "D" dated July 2007, which is attached to this Amendment One.

Except as otherwise expressly provided for herein, the SGIA will continue in full force and effect in accordance with its terms.

NRG and CenterPoint Energy have caused this Amendment to be executed in several counterparts, each of which shall be deemed to be an original but all shall constitute one and the same instrument.
