Notice of Non-Material Change in Facts**

Dear Secretary Bose:

Pursuant to Section 366.7(c) of the regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), 18 C.F.R. § 366.7(c) (2016), Grandview Wind Farm, LLC ("Grandview") hereby notifies the Commission of a non-material change in facts concerning Grandview's status as an Exempt Wholesale Generator ("EWG"). The change in facts arises out of the assignment and assumption of passive, non-voting ownership interests in Grandview to a third party ("Transaction"). As explained below, the Transaction does not affect Grandview's status as an EWG.¹

II. CHANGE IN FACTS

Grandview previously explained to the Commission that EFS Grandview, LLC acquired passive, non-voting ownership interests in Grandview.²

The non-material change in facts arises from the closing of a Transaction, on June 2, 2016, whereby EFS Grandview, LLC assigned its non-voting ownership interests in Grandview to GRP II Vista I LLC, which is a BlackRock fund.

This non-material change in facts does not affect the status of Grandview as an EWG. Other than as discussed above, all the information in Grandview's notice of self-certification remains the same. Grandview continues to be engaged exclusively in the business of owning and/or operating the same "eligible facility" and selling electric energy at wholesale. Grandview submits this notice to ensure that the Commission's records accurately reflect this updated information.

III. CONCLUSION

WHEREFORE, Grandview submits this notice of non-material change in facts and for the reasons explained above notifies the Commission that this change in facts does not affect the EWG status of Grandview.
