

Please accept for filing in the above-referenced proceeding the Performance Measure filing report of Constellation New Energy, Inc. ("Constellation") for the third quarter of 2005. The measures required for retail electric providers ("REPs") are:

Measure A-1 Customers served by Non-Affiliated REPs Measure B-3 Billing Success

Attached is the required report attestation, which is being filed publicly. Constellation is also submitting confidentially and under seal the information for the two measures set forth above. Constellation is submitting this confidential information under seal consistent with PUC Proc. R. 22.71. Constellation notes that in connection with Measure A-1, which requires it to file both paper and electronic copies of its DOE EIA-826 reports, Constellation has submitted only the paper copies of these reports because it considers these reports to constitute confidential information. Procedural Rule 22.71 (d)(3) provides that a party shall not file confidential materials electronically unless specific arrangements are made and agreed to by the parties involved on a case-by-case basis. Constellation is unaware of any such arrangements having been made. Accordingly, Constellation is not filing the EIA-826 forms electronically at this time. Should the Staff desire to review electronic copies of those reports, Constellation will discuss appropriate arrangements for filing such materials in consideration of the rule.
