SUBMISSION REQUIRED BY ORDER NO. 11


Comes Now South Texas Electric Cooperative, Inc. (STEC) and files its submission required by Order No. 11. STEC supports Staff's suggested aggregation of issues 3-8 and 9-15. Since STEC supports Staff's position on issues 3, 4, 6, and 7 and takes no position on issues 5 and 8, it will rely on Staff's witness to address these issues. However, Mike Troell, STEC's Manager of Wholesale Marketing and its Qualified Scheduling Entity, will be available to answer any questions that the Commissioner's may want to pose to STEC concerning these issues.

STEC does desire to serve on the panel to discuss issues 9-15, the issues concerning PCRs. STEC is not totally aligned with any other party concerning these issues. STEC's basic position is that the ERCOT report concerning these issues should be adopted. The other aligned parties support a modification of the report. Should the Commission not adopt the ERCOT Report in its entirety, STEC offers compromise positions that differ from other market participants. STEC requests the opportunity to present its views on its support of the ERCOT report concerning the PCRs as well as its compromise positions.

Mike Troell, STEC's Manager of Wholesale Marketing and Qualified Scheduling Entity will be available to serve on the panel concerning PCR issues. Mr. Troell's resume is attached.
