SUBMISSION REQUIRED BY ORDER NO. 11

COMES NOW Tex-La Electric Cooperative of Texas, Inc. ("Tex-La"), and files this submission pursuant to Order No. 11, issued June 24, 2002, and would respectfully show the following:

I.

Tex-La is a generation and transmission ("G&T") cooperative providing wholesale power and transmission services to its seven member distribution cooperatives. Three of those distribution cooperatives serve retail load wholly or partly within ERCOT, and Tex-La continues to purchase and wheel approximately 90 MW of wholesale power to ERCOT points of delivery located in the respective retail service areas of Tex-La's member distribution cooperatives. Consequently, in this docket Tex-La is primarily concerned with the treatment of transmission congestion rights ("TCRs"), and more particularly, with the treatment of preassigned congestion rights ("PCRs").

II.


Tex-La does not disagree with the aggregation of decision point list ("DPL") issues as proposed by Public Utility Commission Staff ("PUC Staff"). Tex-La's priority

on the point of DPL issue aggregation is that PCR issues (DPL issues 9-15) are grouped, and considered, together.

III.

Tex-La does not intend to tender an expert witness at the Technical Conference scheduled for July 19, 2002. Tex-La believes that its interests will be adequately represented and addressed by the expert witnesses of other similarly situated parties. However, should questions by the Commission or PUC Staff arise, Tex-La will be represented at the Technical Conference by counsel, who should be able to address any Tex-La-specific inquiries.


