

As a Chief Policy Analyst at the PUCT, my primary responsibilities included performing analyses on various electric industry-related issues, formulating alternatives, and developing recommendations for Commission and/or legislative action; preparing preliminary, interim, and final Commission orders; researching and developing Commission positions on issues before the Federal Energy Regulatory Commission, the Nuclear Regulatory Commission and other federal agencies; structuring and moderating Commission workshops and rulemaking proceedings; preparing reports and/or issues-briefs on electric issues; and providing legislative briefing and support.

Much of my work was focused on electric industry restructuring issues, including the preparation of the following legislative reports:

My primary responsibilities included preparing and defending expert witness testimony in rate case and fuel proceedings; assessing the need for electric utility generating capacity; analyzing fuel procurement practices of electric utilities; and developing fuel price and supply projections.
