



The original and three (3) copies of this letter is submitted on behalf of Cincinnati Bell Any Distance, Inc. ("Company") as notification to the Commission of a change in Company name from Cincinnati Bell Any Distance, Inc. to CBTS Technology Solutions LLC. The Company registered as an interexchange carrier on November 11, 2003, Certificate No. IX010462.

Through a series of Delaware and Texas Secretary of State transactions, Cincinnati Bell Any Distance Inc. has executed a change in corporate form to become a limited liability company and it is now known as "CBTS Technology Solutions LLC." Effective as of September 20, 2017, CBTS Technology Solutions LLC filed, and the Texas Secretary of State accepted, an Amendment to Registration to update the company's name in the Texas records from Cincinnati Bell Any Distance Inc. to CBTS Technology Solutions Inc. A Certificate of Amended Registration was issued reflecting the updated name. Simultaneously, CBTS Technology Solutions LLC filed, and the Texas Secretary of State accepted, (1) an Amendment to Registration to Disclose a Change Resulting from a Conversion or Merger and (2) and Application for Registration of a Foreign Limited Liability Company, to change its name in the Texas records to CBTS Technology Solutions LLC, to change its entity type to limited liability company, and to register in Texas as a foreign limited liability company. A second Certificate of Amended Registration was issued reflecting these changes, effective as of September 20, 2017. Copies of the Certificate of Conversion and the CBTS Technology Solutions LLC's authorization to transact business in the State of Texas are enclosed.

The name change and change in form will have no customer impact. A customer notice in the form of a bill message is being provided to all customers stating: "Cincinnati Bell Any Distance Inc. has converted to a limited liability company and changed its name to CBTS Technology Solutions LLC. This change has been processed by the appropriate authority(ies) in your state. Effective January 1, 2018, you will see this name change reflected on your bills. This change does not affect your service or rates, including any of your rights or obligations." The Company filed an amendment to its Service Provider Certificate of Operating Authority to change the Company name in Docket No. 47716 and the Commission has approved the name change as of November 28, 2017. The Company requests that the Commission's interexchange carrier records be updated to reflect this name
