BRAZOS ELECTRIC'S REQUEST FOR PREHEARING CONFERENCE FOR ESTABLISHEMENT OF A PROCEDURAL SCHEDULE

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Now comes applicant Brazos Elective Power Cooperative, Inc. ("Brazos Electric"), files this its request for a Prehearing Conference in order to establish a procedural schedule in this matter, including a hearing date if necessary for Interim Implementation, and would show as follows:

I.

Pursuant to request of Staff in its Response to Order No. 2, Brazos Electric proposed a Procedural Schedule to PUC Staff, the City of Garland, and AEP (the only Intervenors and movants for intervention at that time) for consideration. The Parties have been unable to agree completely on the Procedural Schedule. Brazos Electric and Staff have discussed and agreed to request a Prehearing Conference to set the Procedural Schedule, including a date -- if necessary -- for a Hearing on Interim Implementation on July 2, 2002, as requested in the clarified Statement of Intent To Change Rates For Wholesale Transmission Service.

II.

Brazos Electric has entered into discussions with the City of Garland, AEP and TXU as to the Interim Implementation issue. AEP has indicated that it has no objection to Interim Implementation. The City of Garland and TXU have not given a definitive answer as of this date. As of the time of this filing, no party has opposed interim implementation as of Brazos Electric's corrected effective date, July 2, 2002. (See Brazos Electric's May 31, 2002 Clarification at 1.)

III.

Staff and applicant Brazos Electric have agreed on July 8 for a Prehearing Conference. Therefore, Brazos Electric respectfully requests that a Prehearing Conference be set for July 8, 2002 and that notice be given to Intervenors as to such Prehearing Conference, and that prior to or at the prehearing conference the ALJ grant Brazos Electric's request for interim implementation, effective July 2, 2002, unless any party opposes it.

WHEREFORE, PREMISES CONSIDERED, Brazos Electric prays that the ALJ set a Prehearing Conference on July 8, 2002, as set out herein, or such other date as soon after July 8 as the ALJ shall deem appropriate, and that prior to at the prehearing conference the ALJ grant Brazos Electric's request for interim implementation, effective July 2, 2002, unless any party opposes it.
