# **NOTICE**

On May 24, 2002, Brazos Electric Power Cooperative, Inc. ("Brazos Electric") filed with the Public Utility Commission of Texas ("Commission") its Application to Change Rates for Wholesale Transmission Service pursuant to PUC Subst. R.25.191-203.

Brazos Electric previously made a Transmission Cost of Service ("TCOS") filing that was approved in PUC Docket No. 15641, *Brazos Electric Power Cooperative, Inc.'s Filing in Compliance with Subst. R. 23.67.* A TCOS in the amount of \$35,992,084 was approved in Docket No. 15641 and has been used for calculating transmission service charges owed to Brazos Electric for the years 1997, 1998, 1999, 2000 and 2001.

This Application is based on a historical test year ending on December 31, 2001. Brazos Electric has requested an effective date for the rate change of June 28, 2002. Brazos Electric's TCOS for the test year period is \$43,115,692. The requested change proposes an increase in rates corresponding to the revised TCOS will result in approximately \$7,123,608 of revenue annually for Brazos Electric above the level established in Docket No. 15641. Brazos Electric has requested an interim rate with an effective date of June 28, 2002 and thereafter for any period of suspension ordered by virtue of the Commission's regulatory authority under PURA § 36.108.

# CLARIFICATION TO STATEMENT OF INTENT TO CHANGE RATES FOR WHOLESALE TRANSMISSION SERVICE

#### TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW Brazos Electric Power Cooperative, Inc. ("Brazos Electric") and files this its Clarification to Statement of Intent to Change Rates For Wholesale Transmission Service, and would respectfully show the following:

- It was contemplated that the original Statement of Intent to Change Rates for Wholesale Transmission Service filed in Docket No. 25960 would be filed on May 24, 2002. Due to extremely heavy holiday traffic, it was impossible to complete the filing before 5:00 p.m. Instead, the filing was made on the next business day, May 28, 2002.
- 72. By virtue of the delay in filing, the correct calculation of the requested effective date is July 2, 2002 in Paragraph 8 to such Statement of Intent and the accompanying Wholesale Transmission Service Tariff.
- 3. For purposes of intervention, the correct filing date for the Statement of Intent to Change Rates for Wholesale Transmission Service filed by Brazos Electric is May 28, 2002, for purposes of calculating the intervention deadline (normally 45 days after the date the application is filed, which is July 12, 2002, or such other date as the Commission may prescribe).
- 4. Brazos Electric has this date served notice of this Clarification to the Statement of Intent to Change Rates for Wholesale Transmission Service by serving a copy of this statement to the persons listed on the Exhibit "A" attached to the original filing.
