**BRAZOS ELECTRIC POWER COOPERATIVE, INC.'S LIST OF ISSUES**

On July 9, 2002, the Public Utility Commission ("Commission") issued, through its Policy Development Division, its Order of Referral and Request for List of Issues that is related to the application to change rates filed by Brazos Electric Power Cooperative, Inc. ("Brazos Electric") on May 28, 2002. The Order directed Brazos Electric to file a list of issues by July 15, 2002. Brazos Electric proposes the following issues that should be addressed, issues that should not be addressed, and issues that should be briefed for purposes of a preliminary order:

**ISSUES RELATED TO INTERIM RELIEF**

**ISSUES THAT SHOULD BE ADDRESSED**

1. Does good cause exist to grant interim rate relief as requested by Brazos Electric taking into account PUC Proc.R. §22.125?

**ISSUES RELATED TO FINAL RELIEF**

**Cost of Service**

1. What is Brazos Electric's reasonable and necessary cost of providing transmission service?
2. Have transmission rates, as proposed by Brazos Electric, been properly calculated pursuant to PUC Subst. R. 25.192?

**ISSUES THAT SHOULD NOT BE ADDRESSED**




