SUPPLEMENTAL RESPONSE TO ORDER NO. 1

COMES NOW, the Staff (Staff) of the Public Utility Commission of Texas (PUC or Commission) and files this Supplemental Response to Order No. 1, and would respectfully show as follows:

I.

Staff filed its Response to Order No. 1 on June 11, 2002. It that Response, Staff addressed certain deficiencies that Staff believes exists with regards to information that should be part of Schedules B, C, D, E and F in Brazos Electric Cooperative, Inc.'s (Brazos) application. After discussions with Brazos, Brazos has assured Staff that it will provide information supplemental to its filing in a format that meets with the non-IOU TCOS rate filing requirements and that addresses Staff's concerns. Based on this assurance from Brazos and upon Brazos providing this additional information, Staff does not identify any further material deficiency in the Application at this time.

II.

Staff continues to discuss with Brazos the processing of its application at the Commission. Particularly, Staff and Brazos are engaging in discussions concerning Brazos' motion for interim relief filed with its Application. The ultimate timing and manner in which this motion is addressed will affect any procedural schedule proposed. Additionally, on June 10, 2002, the City of Garland filed a motion to intervene in this docket. Staff would like the

opportunity to further discuss further with Brazos and initially with Garland the motion for interim relief and a proposed procedural schedule. Staff will endeavor to provide the ALJ with an agreed procedural schedule as soon as possible, to extent agreement is possible.

WHEREFORE, PREMISES CONSIDERED Commission Staff respectfully requests entry of an order consistent with Staff's recommendations and requests contained herein.
