NOTICE OF WITHDRAWAL OF CENTERPOINT ENERGY'S FIFTH RFI TO THE CITY OF HOUSTON

Texas Genco, LP and CenterPoint Energy Houston Electric, LLC's (collectively, "CenterPoint") filed its fifth set of RFIs to the City of Houston ("COH") on January 9, 2003. Pursuant to the provisions of Order No. 11 in this proceeding, CenterPoint Energy's fifth set contained questions identical to the second set of RFIs to COH. Since that time, COH and CenterPoint Energy have reached agreement regarding the questions in CenterPoint Energy's second and fifth sets of RFIs, and have reflected that agreement in the letter agreement filed in this docket on January 16, 2003. CenterPoint Energy therefore withdraws its fifth set of RFIs to COH.
