CENTRAL POWER & LIGHT COMPANY'S 60 DAY NOTICE FILING AND REQUEST FOR DECLARATION OF APPROPRIATE TERM OF ENTITLEMENTS FOR THE SEPTEMBER CAPACITY AUCTION

The purpose of this notice is to provide information about Central Power and Light Company's (CPL's) request for the Public Utility Commission of Texas (PUCT or the Commission) to set an appropriate term for entitlements for the September 10, 2002 capacity auction.

CPL requests the Commission to determine that no entitlements are required to be auctioned by CPL in the September 10, 2002 auction. CPL is committed to the divestiture of 1354 MW of generation capacity pursuant to the Integrated Stipulation and Agreement approved by the Commission in Docket No. 19265, Application of Central and South West Corporation and American Electric Power Company, Inc. Regarding Proposed Business Combination. Substantive Rule 25.381(d) exempts from the capacity auction companies that are making divestitures in compliance with a Commission "order in a business combination proceeding pursuant to PURA § 14.101." Docket No. 19265 contains such an order.

Substantive Rule 25.381(h)(3)(C) authorizes companies that are undergoing a divestiture to "petition the commission to set an appropriate term for entitlements." The September auction is designed to auction one-year strips and 12 calendar monthly strips for the year 2003. SUBST. R. 25.381(h)(3)(B)(iii). Under CPL's current divestiture plans, the divestiture will be complete by the end of the first quarter of 2003. Therefore, participation in the September auction would require CPL to auction capacity for a duration that exceeds CPL's auction requirement under the rules and would require CPL to effectively transfer much more than its statutorily obligated 15% to other parties. CPL does intend to participate in the November 2002 auction and will offer monthly entitlements for the first four months of 2003. CPL therefore requests that the Commission declare that CPL is not obligated to offer annual or 12 calendar monthly strips in

the September auction. CPL requests that this notice and request for declaration of appropriate term be processed in accordance with Substantive Rule 25.381(h)(2)(B)(i).

CPL is posting this notice filing and request for declaration of appropriate term of entitlements on the CPL PGC's web site at HTTP://AUCTION.CPLCO.COM. In addition to this notice, that web site also provides a link to the PUCT's Capacity Auction Rules in Section 25.381 of the PUCT's Substantive Rules.
