Dear Service Provider:

According to the records of the City of Conroe, you may be a service provider in one or more of our 2014 annexation territories. The City of Conroe proposes to annex these territories in December of 2014. Chapter 43 of the Texas Local Government Code requires that a notice be sent to each service provider within the territory to be annexed. Maps of all annexation territories are attached for your reference.

Public Hearings on the proposed annexation are scheduled to be held at **2:00 p.m. on Wednesday, November 12th** and at **6:00 p.m. on Thursday, November 13th**. Both Public Hearings will take place in the City Council Chambers of the City Hall (Conroe Tower, First Floor), located at 300 West Davis in Conroe, Texas 77301. You are invited to attend the Public Hearings and comment on the proposed annexation. During the Hearings, the City will provide hardcopies of the Service Plan for this annexation. However, a copy of the Service Plan will be available on the City's website at www.cityofconroe.org before the scheduled hearing dates. You may periodically check our website for the Service Plan's posting. To access the 2014 annexation information and Service Plans, when posted, go to www.cityofconroe.org under Departments and click on Community Development, and then on Planning, and then, Annexation Program.

If you wish to comment during the Public Hearings, you will need to fill out a Citizen Inquiry Form, available in the Council Chamber before each Hearing. You will need to submit the Citizen Inquiry Form prior to the meeting to the City Secretary or another City Official.

Please be aware that the attached four 2014 annexation parcels are immediate annexations, and concludes when the City Council formally adopts an Ordinance on **December 11, 2014**. Once adopted, the annexation becomes effective immediately.

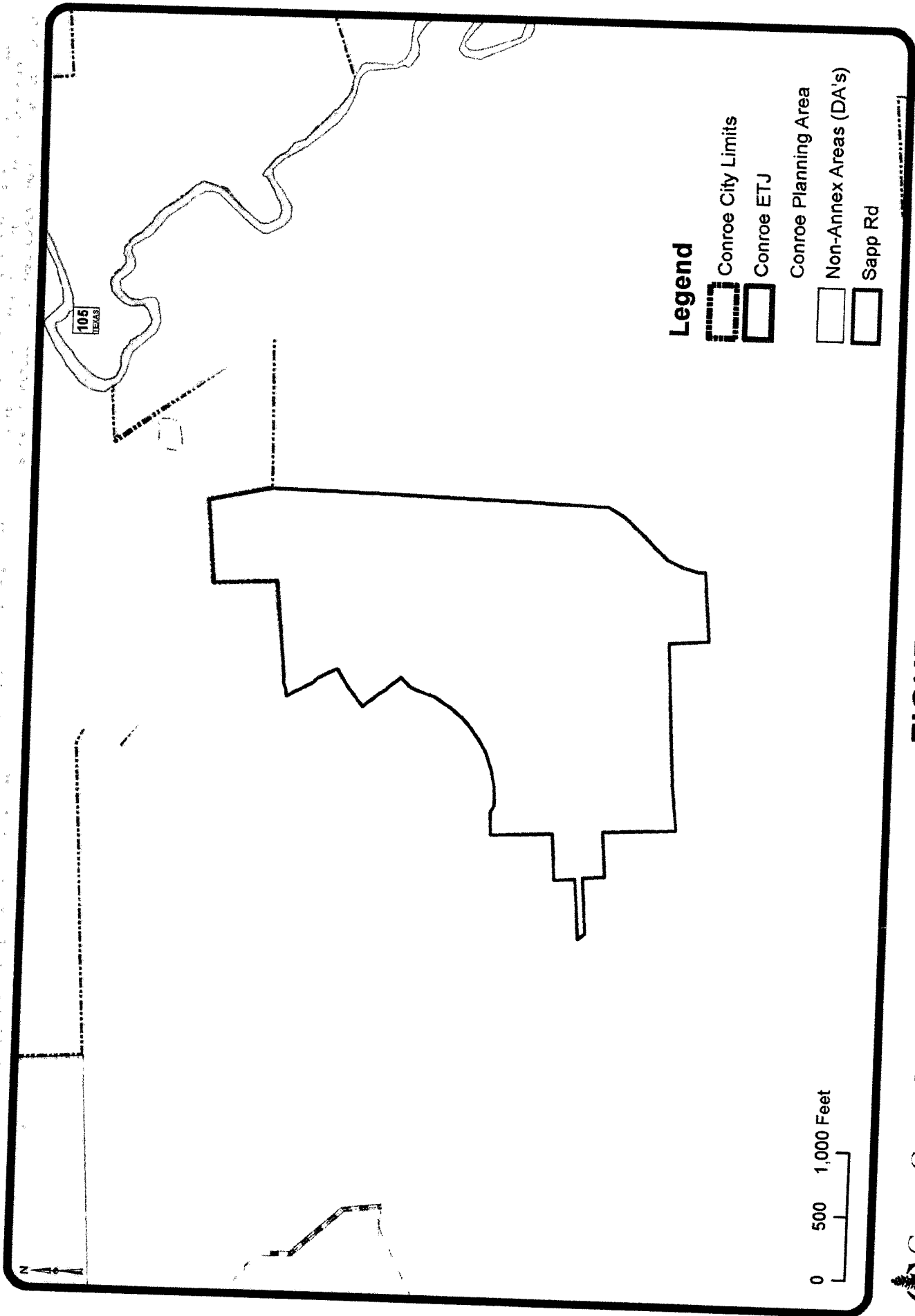

Conroe City Limits

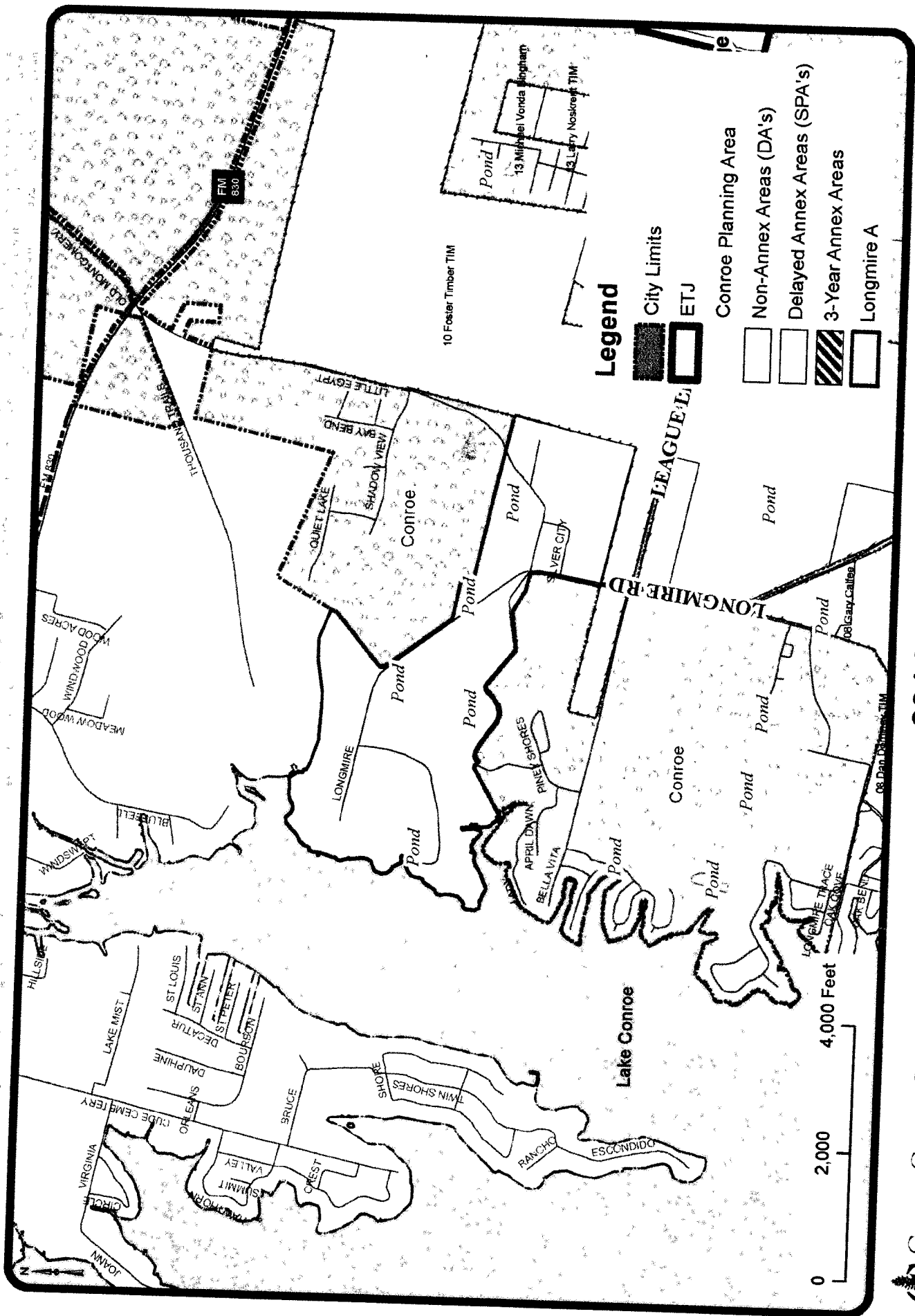

Non-Annex Areas (DA's)

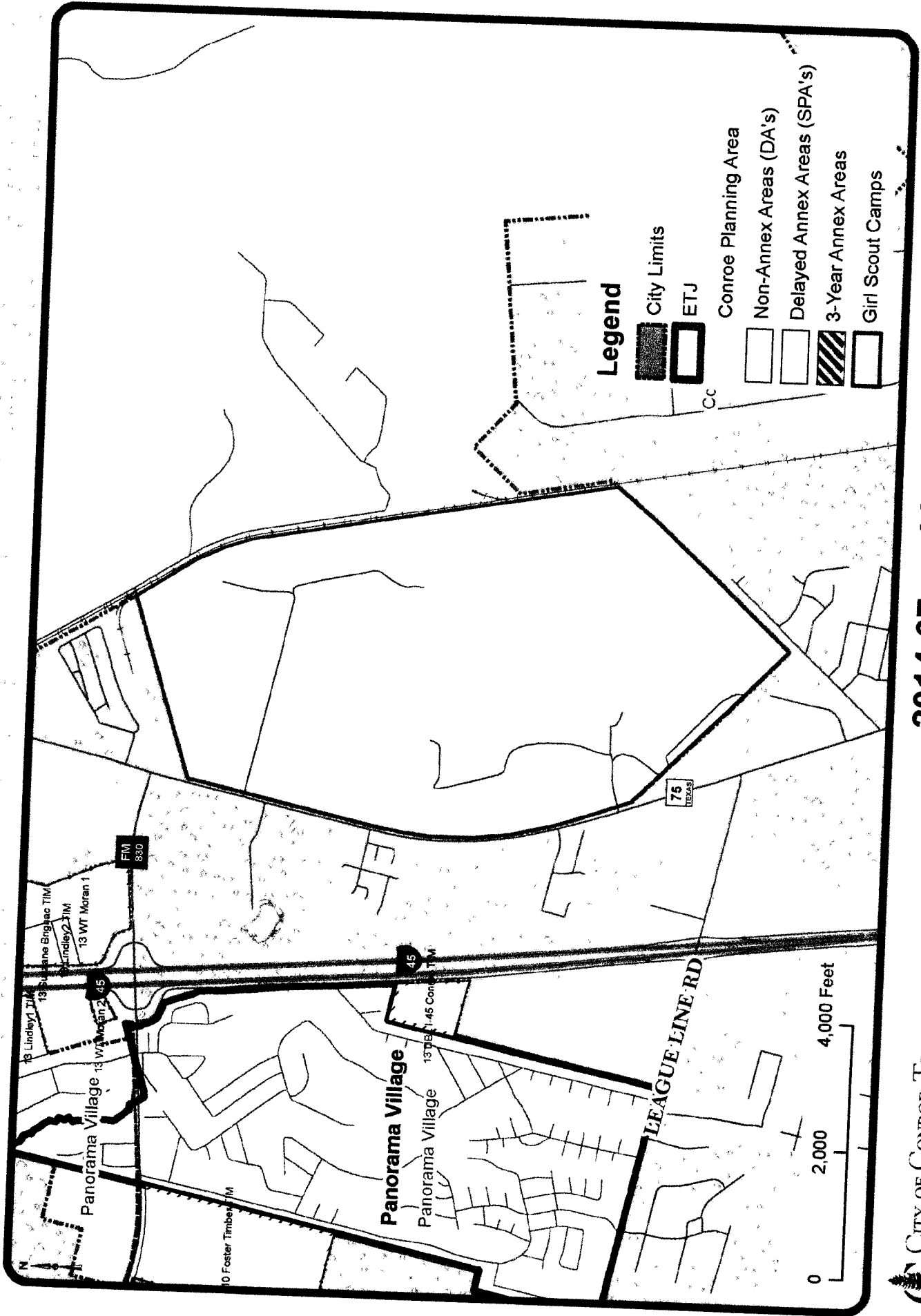
