AN ORDINANCE ORDERING DISANNEXING THE HEREINAFTER DESCRIBED TERRITORY FROM THE CITY OF GRANITE SHOALS, TEXAS AND ALTERING THE BOUNDARIES OF THE CITY TO EXCLUDE SAID HEREINAFTER DESCRIBED PROPERTY FROM THE CITY LIMITS.

WHEREAS, the governing body of the City of Granite Shoals, Texas, has been duly petitioned by a majority of the landowners and qualified voters in the area proposed to be disannexed under the provision of V.T.C.A., Local Government Code, Section 43.033, Sub Paragraph (b); and

WHEREAS, after hearing arguments for and against same, the governing body, by a majority vote, has approved such disannexation from the City of Granite Shoals;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRANITE SHOALS, TEXAS:

SECTION ONE:


