CONTROL NO. 27385 NONDOMINANT INTEREXCHANGE CARRIER REPORT OF SERVICES, LOCATIONS AND RATES COMMUNICATION TELEFONICAS LATINAS CORP

DESCRIPTION OF SERVICES:

Communication Telefonicas Latinas Corp ("CTL") will resell the tariffed services of a facilities-based carrier certified to provide interexchange services in Texas. By reselling network services of other carriers, CTL will provide "switchless resale" of interexchange services to residential and business customers. To obtain its underlying carrier's services, CTL must commit to purchase a high volume of service. CTL must then market and service the customers of the service it resells. CTL's underlying carrier will provide all telecommunications facilities and services in accordance with the underlying carrier's officially filed tariffs.

SERVICE AREA

CTL intends to offer its services throughout the State of Texas to residential and business end users. CTL's services are not intended to be limited geographically within the State of Texas.

RATES

a. Basic Calling Plan.

Company's Basic Calling Plan offers 1+ calls feature rates that are time-of-day and distance insensitive and are available to all areas with equal access. Billing is in full minute increments and are rounded to the next full minute increment.

For the first and each additional minute or fraction thereof, the following rates apply:

Rate per minute:

\$0.12

Monthly fee:

\$4.95

ADMINISTRATIVE CHARGES

Directory Assistance

A Directory Assistance charge of \$0.95 per call applies whether or not he requested number is provided. Up to two requests for listings within a single area code may be made on each call to Directory Assistance. If the Directory Assistance attendant is asked to dial the requested number, a charge of \$0.50 applies whether or not the called party answers.

Texas Universal Service Fund Surcharge

A monthly charge required to fund the Universal Service contribution obligations imposed by Texas P.U.C. Subst. R. 23.150 is applicable to each customer as follows:

Total Monthly Intrastate Charges per Invoice multiplied by 3.4%, minus 911 service fee

Late Payment Charge

A late fee of 1.5% per month or the maximum allowed by law will be charged on any past due balance.

Returned Check Charge

Carrier charges a fee of \$20.00 for any check returned for insufficient funds.

Method of Computing Charges

If any charge includes a fraction of a cent, the fraction is rounded up to the next whole sent (e.g., \$1.4266 would be rounded up to \$1.43).
