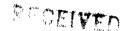

DIRECT TESTIMONY OF RODOLFO CANTU

ON THE LOW-INCOME WEATHERIZATION PROGRAM

Q. Please state your name and business address.

A. My name is Rodolfo Cantu. My business address is 4760 Old Brownsville Road, Corpus

Christi, Texas, 78405.

Q. Please provide the name of your employer and the capacity in which you are employed.

A. I am employed by Nueces County Community Action Agency as the community services

director.

Q. Please explain the purpose of Nueces County Community Action Agency and your

responsibilities.

A. Nueces County Community Action Agency (NCCAA) is a private, non-profit corporation

that offers a wide variety of programs for the poor. The programs include Community

Services, Weatherization, Utility Assistance, Housing Information and Referral, Head

Start and Early Head Start. As the community services director, I am responsible for all

of the agency's delivery of social services and report to the executive director.

Q. Please explain your qualifications to testify in this proceeding.

A. I have been employed at NCCAA since September 1993. In my capacity as community

services director I oversee all community services programs. My experience in this

capacity includes overseeing all activities of our weatherization program including

budget preparation, client eligibility, contracting for services, planning, scheduling and

measuring production, and preparing reports to the Texas Department of Housing and

Community Affairs.

Q. What is the purpose of your testimony?

A. This testimony is to explain the impacts in our community of losing the system benefit

funds dedicated to weatherization and the need for weatherization services in our

community.

O. Do you have exhibits attached to your testimony?

A. Yes. Please see Exhibits RC-1 and RC-2

O. Please provide the amount of weatherization funding your agency received when

weatherization was funded by Central Power & Light Company and the amount provided

under the system benefit fund.

A. In the period 4-1-2001 through 12-31-2001, NCCAA received funding in the amount of

\$105,136. At this time, Central Power & Light Company through the CPL

HOMESAVERS PROGRAM funded weatherization. Through the lifetime of the

HOMESAVERS PROGRAM, several thousand CFLs and water savers were installed

and enhanced the energy savings of our low-income clients.

In the period 1-01-02 through 8-31-02, NCCAA received \$185,717 of system

benefit funds for weatherization. NCCAA implemented the SBF program to achieve a

prescribed level of assistance for eligible low-income personnel (at 125% of the poverty

level), particularly the elderly, disabled, and households with young children and in

accordance with the provisions of the system benefit fund Low-Income Energy

Efficiency Plan.

In 2003, NCCAA received \$314,682 from the system benefit fund for

weatherization, refrigerators, compact fluorescent lights and water savers.

Q. In 2003 what were NCCAA's expenditures of the weatherization system benefit funds?

A. As reported to the managing agency, the Texas Department of Housing and Community

Affairs, 99.02% of the weatherization funds were expended to weatherize 110 units, at an

average cost of \$2,179.15; 100% of the refrigerator funds were expended to replace 108

inefficient refrigerators with Energy Star rated refrigerators. One hundred percent of

budgeted funds, \$2,243.00, benefited 160 households by replacing 500 incandescent light

bulbs with compact fluorescent bulbs and installing 200 water saving faucet aerators and

45 water saving showerheads.

Q. How has the loss of funding impacted your agency and your low-income clients?

A. The loss of system benefit fund funding has resulted in the reduction in the number of

low-income families assisted. It is estimated that approximately 115 low-income families

lost the opportunity to save on energy. By using the SBF funds in coordination with the

federal program our results show that families have achieved a 30 percent total energy

savings.

Q. How has the loss of funding impacted your community?

A. The overall low-income community has been impacted by the loss of the system benefit

fund weatherization program. Now, other like social service programs have taken a more

restrictive look as to how the low-income are assisted – if at all due to their budget

constraints. There is no other weatherization program to speak of in the community that

assists low-income families with their weatherization needs. The City of Corpus Christi

provides Community Development Block Grant dollars which are piggy-backed with

U.S. Department of Energy and LIHEAP dollars to help alleviate the problem – but the

funds are not sufficient to replace the level of funding provided by the system benefit

fund.

Q. Can you provide some representative examples of how individual clients have been

affected?

A. Yes. With the system benefit fund we were able to assist a 46-year-old man who suffered

a stroke three weeks after he was laid off of his job. He was unable to collect

unemployment and his social security supplement was pending. The walls of the home

were in various stages of deterioration and had to be completely changed out. Exhibit RC

1 has photographs of the condition of the rear exterior of the house before repairs were

made and the front corner of the house midway through the repairs. Insulation was added

to the walls and ceiling, and windows and doors were replaced. This client now has an

electric bill that shows a 30 to 40% decrease in total cost and a 30% decrease in heating

cost. The work done on the home saves money that would have been spent on electric

and gas. The client also benefits from better comfort levels and a healthier environment

that prevents colds and other illness for this disabled man. By end of year 2003 this

client was granted Supplemental Social Security benefits, but due to his age he continues

to be at 60% of median income. The assistance given with the System Benefit Program

can not be measured. Today this client's home would be denied.

Another example is an elderly woman, living alone. Because of deteriorated

windows and doors there was too much air infiltration. There was no insulation in the

walls and attic. Exhibit RC-2 contains photographs of the rafters in the attic without and

with insulation and a photograph of insulation being blown in the attic. Before the

weatherization improvements were made the cost of keeping the home warm in winter

and cool in the summer were beyond what the client could afford. After weatherization

the client's utility costs were lowered by 40%. Before weatherization this client would

now enjoys has decreased her need to seek help. Today, without the SBF program we

would not be able to insulate the home and do other home repairs because the cost would

exceed the federal program's spending cap.

Q. What would you like to see the Public Utility Commission order AEP Texas Central

Company to do in regard to the low-income weatherization program?

A. The need for weatherization funds far exceeds our resources and we would ask that the

2003 level of funding provided under the system benefit fund be restored.

Q. Does that conclude your testimony?

A. Yes.

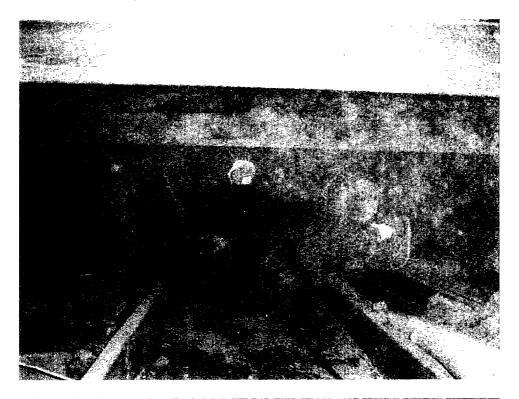

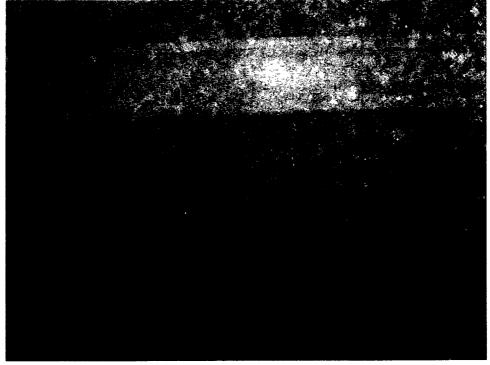
