With respect to the status of the Docket 20381 remand since the status report filed last month, San Antonio would show the Commission as follows:

In the appeal of Docket No. 20381 pending in the Texas Court of Appeals for the Third District at Austin in cause No. 03-02-00701-CV under the style *Texas Municipal Power Agency; City of Denton; City of Garland; and GEUS f/k/a Greenville Electric Utility System, Appellants v. Public Utility Commission of Texas; City of Bryan; and City of Weatherford, Appellees*, since the overruling of the Appellants' motion for rehearing on July 15, 2004, no further action has occurred in that court, and its mandate is scheduled to issue on September 24, 2004. Under the Texas Rules of Appellate Procedure, a petition for review may be filed in the Texas Supreme Court within 45 days following the date of the court of appeals' last ruling on timely filed motions for rehearing.
