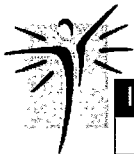

Enclosed for filing please find the Quarterly Wholesale Electricity Transaction Report ("QWETR") pursuant to § 25.93 for Hays Energy Limited Partnership (the "Company"). Certain information contained in the QWETR is **protected information**, as that term is defined in Section 25.93. Specifically, ANP believes that the following information requested on the QWETR form is exempt disclosure under the Texas Public Information Act, Texas Gov't Code Chapter 552, because, as defined in §552.110, it is commercial or financial information the disclosure of which would cause substantial competitive harm to the Company or its counterparties; and because as defined in §552.104, release of this information would give advantage to a competitor or bidder. The specific information for which protection is requested is as follows (1) the Transaction Beginning Date; (2) the Transaction Ending Date; (3) the Receipt Zone; (4) the Delivery Zone; (5) the Increment; (6) the Product Name; (7) the Quantity; (8) the Price and (9) the Total Charge.

As a result of this request for confidentiality, pursuant to §25.93(g), the Company has provided public reports on compact disk (2 copies) as required, which are attached as Exhibit 1.


