Pursuant to P.U.C. SUBST. R. 25.93, Occidental Power Services, Inc. ("OPSI") hereby submits its Quarterly Wholesale Electricity Transaction Report ("Report") for the first quarter of 2010. More particularly, this material includes, but is not limited to, information which is confidential pursuant to non-disclosure agreements, market-sensitive material which is company specific, and/or information of highly commercially sensitive nature involving company business operations or financial information. The information in this Report is not widely available or known outside of OPSI, is information that OPSI has spent considerable time and effort in acquiring and/or analyzing, and such information and/or analysis would be of considerable value to competitors of OPSI to the serious detriment of OPSI.


