In accordance with the Orders in Project No. 29298 and P.U.C. Subst. R. 25.93, Calpine Corporation ("Calpine") is providing the enclosed Quarterly Wholesale Electric Transaction Report ("QWETR") for the fourth quarter of 2010 for Texas City Cogeneration, L.P. The information is provided as attached Public Report [defined at 25.93(c)(4)] version compact disks (two copies), the electronically submitted Full Report [defined at 25.93(c)(2)] version, and the confidentially filed Full Report version compact disks (two copies).

Calpine considers identification of the counterparties, contract expiration information, the revenue, price and MWhrs of electricity sold, and the total value of each transaction reflected in these reports to be privileged and confidential trade secrets, and commercial and financial material, of which public disclosure would cause significant and substantial harm to Calpine and its commercial partners. Therefore, this information is being filed pursuant to the provisions of P.U.C. Subst R. 25.93(e) & (g) and P.U.C. Proc. R. 22.71(d). As such, Calpine requests the Commission treat the material described above as Protected Information [defined at 25.93(c)(3)], and as confidential material exempt from public disclosure under the Texas Public Information Act, Texas Government Code, Ch. 552, Sections 552.101 and 552.110.

Based on the aforementioned points I affirm that any assertions of confidentiality regarding this QWETR have been made with a good faith belief that an exception to public disclosure under Chapter 552 of the Texas Government Code applies to the information provided, and such QWETR should be treated confidentially by the Commission and its staff. I also affirm that the contents of this report were prepared under my direction, and that the contents of the QWETR are true, complete, and correct.
