Dear Sir or Madam:

Please find enclosed one CD-ROM containing the redacted, non-confidential version of BNPP ET's Quarterly Wholesale Electricity Transaction Reports for the period April 1, 2011 through June 30, 2011 in accordance with 16 TAC § 25.93. Also find enclosed in two separate sealed envelopes, in accordance with 16 TAC § 22.71, unredacted versions of BNPP ET's Quarterly Wholesale Electricity Transaction Reports containing information BNPP ET deems to be confidential.

The information BNPP ET deems confidential includes the name of the counterparty to each wholesale electricity transaction, and the price associated with such transaction. BNPP ET deems this information to be confidential for several reasons. First, BNPP ET has agreed in its wholesale trading contracts to reasonably maintain the confidentiality of transaction information. Second, such information is considered by BNPP ET to be trade secret information the disclosure of which would cause material commercial harm to BNPP ET. That is, the counterparties with whom BNPP ET trades and the price at which it trades could, if publicly disclosed, provide BNPP ET's competitors the ability to price transactions as they otherwise would not, either undercutting BNPP ET's efforts to engage in wholesale trading activities or perhaps causing BNPP ET to pay more for power than it otherwise would. Therefore, in accordance with the Texas Public Information Act, Tex. Gov't Code § 552.110, BNPP ET requests confidential treatment of the name of the counterparty to each wholesale electricity transaction, and the price associated with such transaction.

Finally, please find enclosed the Attestation of Rita Wynne with respect to BNPP ET's Quarterly Wholesale Electricity Transaction Reports.
