A. Reliant Resources, Inc. and its subsidiaries are not affiliates of CenterPoint or Texas Genco under general principles of corporate or securities law. Nevertheless, RRI and its subsidiaries are considered affiliates of CenterPoint and Texas Genco under certain portions of PURA and the Business Separation Plan. Capacity, energy, and ancillary service transactions between Texas Genco and RRI or its subsidiaries from January 2002 through December 2003 were previously provided on March 31, 2004 and can be found in the confidential workpapers for General Instruction 6(g) at Bates Stamp pages 932-3200. Summary information responsive to this request is provided in the attachment below.
