## SOUTHWESTERN PUBLIC SERVICE COMPANY'S MOTION TO MODIFY ORDER NO. 9

(Filename: 7C3.doc; Total Pages: 3)

Southwestern Public Service Company (SPS) files this motion to modify Order No. 9 and states the following. On September 29, 2004, SPS filed an agreed motion to modify the procedural schedule (Agreed Motion). The Agreed Motion contained the revisions to the procedural schedule embodied in Order No. 9, except that it stated that discovery on SPS's direct case would end on October 25, 2004, rather than on October 15, 2004, as requested in the Agreed Motion. SPS requests that the date discovery ends on its direct case be changed to correspond to the October 15, 2004, date stated in the Agreed Motion. The Agreed Motion also contained the following request:

The parties also have agreed that rebuttal discovery served on SPS before November 29, 2004, shall be deemed to have been served on SPS on November 29, 2004, for all purposes. Except for this modification, all deadlines related to discovery stated in Order No. 7 shall remain the same.

Although Order No. 9 revised the procedural schedule, it did not contain the equally important agreement of the parties stated above. SPS requests that the Administrative Law Judge issue an order modifying Order No. 9 to include the statement set forth above.

The Agreed Motion was either supported or not opposed by all of the parties to this proceeding and, therefore, there should be no parties that oppose this request.

WHEREFORE, SPS respectfully requests that the Administrative Law Judge issue an order modifying Order No. 9 as set forth above and granting SPS any other relief to which it may be entitled.
