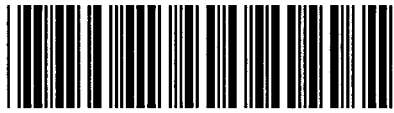

REGARDING LATE-FILED MOTIONS TO INTERVENE**


On March 3, 2005, Todd and Stacy Howell filed a request to intervene in this docket. On March 8, 2005, Charles William Stocker, III filed a request to intervene. No party opposed the interventions. Although both motions were filed after the intervention deadline, the Howells and Mr. Stocker indicated that they did not receive notice until recently. Therefore, the motions to intervene are granted.

The new intervenors may view and print all filings except transcripts at the Public Utility Interchange. To access this website: go to <http://www.puc.state.tx.us>, on the left side of the screen, move the mouse over Filings-Interchange then click once on Filings Retrieval, wait for the system to load; then click Login, wait for the system to load; then type 30168 in the box labeled Control Number; then click on Search Now. The screen that loads contains all filings from this case numbered in the order they were received at the Public Utility Commission. To view a document, click once on the Item Number on the left side of the screen, at the next screen, click once on the word "Download." The document will then load, with a cover page. It is possible to scroll through the document using the up and down arrows on the right side of the screen. All documents are stored in PDF format, which requires Adobe Acrobat Reader, a free program, to be able to view and print the document, which can be downloaded at <http://www.adobe.com/products/acrobat/readstep2.html>.

The new intervenors must file direct testimony or a statement of position no later than March 21, 2005, if they wish to participate as active intervenors in this case. Furthermore, in order

to learn what must be done to participate in this case, the new intervenors are directed to the Public Utility Commission interchange, using the directions in the above paragraph, to read all orders issued in this case, as well as filing instructions provided by the Staff of the Public Utility Commission.
