
ANNUAL REPORT ON HISTORICALLY UNDERUTILIZED BUSINESSES

Southwest Texas Telephone Company hereby submits its Annual Report pursuant to Substantive Rule 26.80. Southwest Texas Telephone Company (STTC) is a small local exchange carrier located in Rocksprings, Texas. The Small Utilities HUB Use Report is attached to and made a part hereof.

Pursuant to Substantive Rule 26.80(b)(4) STTC submits the following text description of its procedure for determining which of its vendors are HUBs. Each time a new vendor is added to the Accounts Payable system, the Accounts Payable clerk sends the vendor a form (the "HUB form") on which the vendor can designate whether or not it is a HUB, and if so, what category of HUB it is. If the form has not been completed and returned before the first check is produced to pay the vendor, the Accounts Payable clerk calls the vendor and informs it that we have a check ready to send out pending our receipt of the HUB form. If necessary the Accounts Payable clerk will fax another HUB form to the vendor, and will offer to receive the completed HUB form by fax. Upon receipt of the completed HUB form the check is mailed to the vendor and the appropriate notation as to the vendor's HUB status is made in the Accounts Payable system.

The above Annual Report and attached Small Utilities HUB Use Report has been prepared and submitted by the undersigned pursuant to PUC Substantive Rule 26.80.
