1. TYPE OF PLAN:

tw telecom is submitting this Commercial Plan as defined in FAR clause 52.219-9(b), Small Business Subcontracting Plan.

2. GOALS:

In 2010 *tw telecom* is launching a multi-year initiative to identify new diverse sources of supply; bolster and expand the company's ongoing outreach efforts; expand the company's training and education (particularly regarding FAR requirements); and modify its processes to more seamlessly identify and award business to diverse suppliers. *tw telecom* is also expanding the accountability for establishing local goals, outreach efforts, and the identification of new diverse suppliers beyond its key corporate employees to personnel in its Field Offices who also make purchasing decisions. The company has been in the process of strengthening its supplier diversity policy, outreach efforts, data accuracy, and ability to produce, track, and review credible vendor spend data since establishing its own separate Small Business Subcontracting Plan following the sale of Time Warner Inc's controlling interest in the company.

The majority of *tw telecom*'s product spend occurs directly with original equipment manufacturers of hardware and software. Many of these original equipment manufacturers (OEM) from whom *tw telecom* purchases goods have active Small Business Subcontracting Plans (Tier 2 Supplier Diversity Spend). That Tier 2 spend is substantial but has not been captured in the planned subcontracting values stated below. *tw telecom* is working with these OEM vendors (Tier 2 providers) to drive additional business to small and diverse sources and while the current spend with small and diverse businesses resulting from *tw telecom*'s purchases from Tier 2 providers are not currently being reported under this Commercial Plan, *tw telecom* anticipates providing that data in the future. *tw telecom*'s direct small and diverse business subcontracting goals are as follows:

 - Where a gap develops between tw telecom's prior fiscal year spend and tw telecom's current fiscal year spend goal, tw telecom will work to identify the appropriate means and methods to drive business to the diverse supplier business subcategory where the gap exists including:
 - Indentifying opportunities and methods to drive more spend to tw telecom's existing suppliers in the small business subcategory where the gap exits;
 - Identifying new sources of supply through local, national and regional vendor outreach efforts (via *tw telecom* research, business opportunity workshops, minority business enterprise seminars, online diverse supplier databases, trade fairs, etc.)
 - Where gaps *do not* exist between *tw telecom*'s prior fiscal year spend and *tw telecom*'s current fiscal year spend goal, *tw telecom* continues to identify new sources of supply, bidding opportunities, awards, and appropriate embedded diverse supplier development to help meet and/or

exceed tw telecom's goals for the given type of business concern;

- K. tw telecom's subcontracting requirements are established by the overall business needs of the company and, as applicable, the specific requirements of each project. Typically, these goods and services needs cannot reasonably be fulfilled internally. As an example, tw telecom subcontracts for goods and services that: i) are not within tw telecom's core mission to produce but are required for tw telecom to provide services; ii) are variable and/or unpredictable in nature making it imprudent to hire and later layoff personnel who would perform such functions; iii) are from vendors who have specialized knowledge or expertise not resident within tw telecom; or iv) are goods and services that can be obtained more efficiently and/or at a prices not otherwise achievable within tw telecom. tw telecom will to continue to extend subcontracting and new business opportunities to small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small, and small women-owned business concerns based upon tw telecom's ongoing business needs.
- L *tw telecom* determines the capability of small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small, and women-owned small business concerns based upon the vendor's ability to meet *tw telecom*'s specified requirements and overall business needs including the appropriate balance of price, timeliness, quality, technical suitability, economic diversity, and other valid business considerations.

<u>Duties</u>: The Program Administrator's general overall responsibility for *tw telecom*'s subcontracting program performance includes, but is not limited to the following activities:

- A. Developing and promoting company/division policy statements that demonstrate the company's/division's support for awarding contracts and subcontracts to small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned small business concerns.
- B. Developing and maintaining bidders' lists of small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned small business concerns from all possible sources.
- C. Making reasonable efforts to include small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned small business concerns on the bidders' list for subcontract solicitations for products and services they are capable of providing.
- D. Assisting in the design of subcontract procurement "packages" to permit participation of small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small, and women-owned small business concerns.
- E. Documenting *tw telecom's* reasons for not selecting low bids submitted by small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned small business concerns related to a government contract.

5. CLAUSE INCLUSION AND FLOWDOWN

tw telecom will include the clause in FAR 52.219-8, "Utilization of Small Business Concerns," in all government subcontracts that offer further subcontracting opportunities.

tw telecom will use reasonable efforts to insist that all government subcontractors, except small business concerns, that receive government subcontracts in excess of \$550,000 (\$1,000,000 for construction of any public facility with further subcontracting possibilities) adopt a plan that complies with the requirements of FAR 52.219-9, "Small Business Subcontracting Plan."

tw telecom holdings inc. has reviewed clause FAR 52.219-9(d)(9). The acceptability of percentage goals for small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, and women-owned small business concerns will be determined on a case-by-case basis depending on the supplies and services involved, the availability of potential small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, and women-owned small, service-disabled veteran-owned small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned small business subcontractors and prior experience. Once the plan is negotiated, approved, and implemented, tw telecom understands that it will be monitored through the submission of

periodic reports, including Summary Subcontracting Reports through the eSRS website.

tw telecom understands that in accordance with policy letters published by the Office of Federal Procurement Policy, procedures for the review, approval and monitoring for compliance with this subcontracting plan must be described.

6. REPORTING AND COOPERATION

tw telecom will (1) cooperate in studies or surveys as may be required; (2) submit periodic reports which show compliance with the subcontracting plan; (3) submit Summary Subcontracting Reports through the eSRS website; and (4) ensure that subcontractors agree to submit Individual Subcontracting Reports and Summary Subcontracting Reports through the eSRS website.

7. <u>RECORDKEEPING</u>

tw telecom is working toward documentation standards that will allow it to maintain records reasonably demonstrating the procedures adopted to comply with the requirements and goals in the subcontracting plan including:

- A. Small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned small business concern source lists, guides, and other data identifying such vendors.
- B. Organizations contacted for small, HUB Zone small, small disadvantaged, veteran-owned small, service-disabled veteran-owned small, minority-owned small and women-owned business small sources.
- C. For government contracts, records on subcontract solicitations over \$100,000 which indicate for each solicitation:
