(1) Describe the specific initiatives, programs, and activities undertaken under the plan during the preceding year:

During the past year, there was no significant change in the diversity of XIT Rural Telephone Cooperative, Inc.'s (XIT or the Cooperative) workforce from 2007. XIT continues to employ a diverse workforce, emphasizing local community employment.

(2) Make an assessment of the success of each of the specific initiatives, programs, and activities listed above:

XIT maintains a commitment to employ a diverse workforce with emphasis placed on recruiting, training and employing individuals with the education and skill-sets needed from within the local community.

XIT strives to utilize historically underutilized businesses (HUBs) for the procurement of goods and services, especially when the HUB is affiliated or located within its local or surrounding communities. XIT continues to look at the availability of certain products, services and businesses that qualify under the HUB definition through community resource participation and involvement and through use of the state's HUB directory. XIT also aims to utilize small businesses other than those defined as HUBs in the procurement of goods and services. With XIT's emphasis on utilizing and promoting local or surrounding area business economic growth, XIT plans to continue its involvement in local, county and state organizations that promote the use of small businesses.

(3) Describe the initiatives, programs, and activities the utility will pursue during the next year to increase the diversity of its workforce and contracting opportunities for small and historically underutilized businesses:

XIT plans to continue employing a diverse workforce, emphasizing local community employment. Also constraints to maintain its focus on diversity with respect to local hiring and contracting, given the constraints of the Cooperative's rural environment and low turnover rate. While the Cooperative will continue to purchase goods and services based on competitive price, quality and availability, wherever continue to purchase goods and services based on competitive price, quality and availability, wherever possible XIT will continue to do business with HUBs where we have existing relationships and will strive to develop new relationships with HUBs.

(4) State the specific progress made under the plan filed by the utility:

There has been no significant change in the workforce diversity of the Cooperative from the year 2007. XIT continues to utilize all local HUBs and small businesses to the extent possible to meet contracting and procurement needs.
