(3) Construction -- Construction done by general contractors and special trade contractors which includes new work, additions, alterations, reconstruction, installations, repairs, remodeling, renovating, and repair of office buildings. Heavy construction other than buildings such as pipelines, communication and power lines, sewer and water mains, asphalt and concrete construction of roads, trenching, cable laying, conduit construction, land clearing and leveling.

XIT continues to look at the availability of certain products, services, and businesses that qualify under the HUB definition through community resource participation and involvement and through use of the state's HUB directory. XIT also aims to utilize small businesses other than those defined as HUBs in the procurement of goods and services. With XIT's emphasis on utilizing and promoting local or surrounding area business economic growth. XIT plans to continue its involvement in local, county, and state organizations that promote the use of small businesses.

(3) Describe the initiatives, programs, and activities the utility will pursue during the next year to increase the diversity of its workforce and contracting opportunities for small and historically underutilized businesses:

XIT plans to continue employing a diverse workforce, emphasizing local community employment. Also, XIT intends to maintain its focus on diversity with respect to local hiring and contracting, given the constraints of the Cooperative's rural environment and low turnover rate. While the Cooperative will continue to purchase goods and services based on competitive price, quality, and availability, where possible XIT will continue to do business with HUBs where we have existing relationships and will strive to develop new relationships with HUBs.

(4) State the specific progress made under the plan filed by the utility:
