(1) HUB -- Pursuant to Texas Government Code § 481.191(4), HUB means: (A) a corporation formed for the purpose of making a profit in which at least 51 percent of all classes of the shares of stock or other equitable securities is owned by one or more persons who are members of certain groups, including black Americans, Hispanic Americans, women, Asian Pacific Americans, and American Indians; (B) a sole proprietorship formed for the purpose of making a profit that is 100 percent owned, operated, and controlled by a person described by Paragraph (A) of this subdivision; (C) a partnership formed for the purpose of making a profit in which 51 percent of the assets and interest in the partnership is owned by one or more persons described by Paragraph (A) of this subdivision. Those persons must have proportionate interest and demonstrate active participation in the control, operation, and management of the partnership's affairs; or (D) a joint venture in which each entity in the joint venture is a historically underutilized business under this subdivision.

(2) Small Business -- Pursuant to Texas Government Code § 481.191(6), Small Business means a corporation, partnership, sole proprietorship, or other legal entity that: (A) is domiciled in this state; (B) is formed to make a profit; (C) is independently owned and operated; and (D) employs fewer than 100 full-time employees.

(3) Construction -- Construction done by general contractors and special trade contractors which includes new work, additions, alterations, reconstruction, installations, repairs, remodeling, renovating, and repair of office buildings. Heavy construction other than buildings such as pipelines, communication and power lines, sewer and water mains, asphalt and

(4 Commodities -- All materials, goods or tangibles purchased to conduct business, not including fuel or purchased power contracts and major equipment purchases and rentals.

(5) Others Services -- All specialty work, special circumstances that required contract labor, special consultants or other non-defined services. Examples include audio/visual, staffing services, landscaping, forestry, tree trimming, art and decorative services, janitorial, travel/lodging, automotive repair, and photography.

(6) Professional Services -- Contracted professional services which include legal, consulting, health, engineering, accounting, advertising/marketing, architectural, real estate, computer services, research and analysis, education/training, insurance, surveying services, weather services, environmental, financial, etc.

(7) Major Equipment -- Includes all major equipment purchases and rentals including but not limited to transmission and distribution equipment, power plant equipment, substation

(8) Other -- Any commodity or service not covered by the above categories.

(1) Describe the specific initiatives, programs, and activities undertaken under the plan during the preceding year:

Coleman County Telephone Cooperative, Inc. supports all our local businesses when possible. The Cooperative always looks for diversity when considering new vendors. We added different internet speed packages to help keep the basic package as low as possible and cut the installation fee to help in the low income area we serve.

This year we went to a combined one bill system in an effort to formulate a more convenience billing and pay systems for our customers. The cooperative employs a bilingual customer service representative to help serve our Latin-American customers more efficiently.

Concerning the fiber project, we are in the process of switching over Santa Anna (South) over to FTTH and have begun work on the Santa Anna (North) FTTH project.

(2) Make an assessment of the success of each of the specific initiatives, programs, and activities listed above:

Customer number have increase since the lower to no installation fee was imitated. More we are serving a significant increase in customers who are using our credit card and epmt service. Our local businesses seems to be doing ok which helps us all. FTTH has help with speed of service and making customer happy. Customer Service with one call for both phone and internet with one payment should also make customer happy.

(3) Describe the initiatives, programs, and activities the utility will pursue during the next year to increase the diversity of its workforce and contracting opportunities for small and historically underutilized businesses:

We are continuing the FTTH (Fiber to the Home) project that we believe will contribute and add additional traffic business to our small town. We are pursuing the possibility of a project to build a new tower to deploy a "700" frequency in expectations of being able to reach more homes in the outlying areas of several communities in the county. If this project is possible, we will be able to streamline and combine our operations to efficiently serve customers.

CCTC is a small cooperative in a small rural area, with very little turn over.

(4) State the specific progress made under the plan filed by the utility:

CCTC has a very high percentage of small business owners. We use large vendors when there are no other vendors that we can choose from for the job that needs to be accomplished. We have a large vendor count, so we use different diversified vendors. We have continually examined and tried new processes to make services increasingly convenient for our customers. By offering more available and efficient services, we are able to effectively induce more advantages and strengthen the present and future businesses in our rural area.
