On behalf of Mid-Plains Rural Telephone Cooperative, Inc. ("Mid-Plains"), I am submitting two (2) copies of Mid-Plains' Workforce and Supplier Diversity Report ("Workforce Diversity") pursuant to 16 Tex. Admin. Code § 26.85 for filing in the above-referenced proceeding. If such information is divulged, it would cause competitive disadvantage and harm to Mid-Plains and is therefore exempt from disclosure.

Consistent with the requirements of the approved rule, copies of this report are also being provided to the: (1) Governor; (2) Lieutenant Governor; (3) Speaker of the House; (4) Texas Senate Hispanic Caucus; (5) Texas Legislative Black Caucus; and (6) Mexican American Legislative Caucus.
