On behalf of West Texas Rural Telephone Cooperative, Inc. ("West Texas Rural"), I am submitting two (2) copies of West Texas Rural's Workforce and Supplier Diversity Report ("Workforce Diversity") pursuant to 16 Tex. Admin.
