

On behalf of Poka Lambro Telephone Cooperative, Inc. ("Poka Lambro"), I am submitting two (2) copies of Poka Lambro's Workforce and Supplier Diversity Report ("Workforce Diversity") pursuant to 16 Tex. Admin. Code § 26.85 for filing in the above-referenced proceeding. If such information is divulged, it would cause competitive disadvantage and harm to Poka Lambro and is therefore exempt from disclosure.
