On behalf of Mid-Plains Rural Telephone Cooperative, Inc. ("MPRTC" or "Cooperative"), I am submitting two (2) copies of MPRTC's Workforce and Supplier Diversity Report ("Workforce Diversity") pursuant to 16 Tex. Admin.
